# DEA-registered practitioners: UpToDate® meets MATE Act Requirements

U.S. practitioners prescribing controlled substances must complete eight hours of training on treatment and management of patients with opioid or other substance use disorders.



### **UpToDate is MATE Act-eligible:**

- For physicians and physician assistants, UpToDate provides 0.5 hours of credit for each eligible topic viewed. For those who have selected the AMA PRA Credit track for CME, you must research a clinical question from the search box before credits will accrue; you cannot earn AMA credits by clicking to a topic directly from the table of contents.
- Nurse practitioners can use the time-based tracking option in UpToDate for continuing education credits. A search is not required to accrue credit.
- Along with your CME credit certificate, you can access an activity log of the topics you reviewed during the period reflected in the certificate – including those that meet MATE Act requirements.
- Training does not need to occur in one session. It can be cumulative across multiple sessions equal to eight hours.

Topics within the **Substance use disorders** sub-section of the **Psychiatry** specialty in UpToDate are MATE Act-eligible.

Eligible topics include, but are not limited to:

- Approach to treating opioid use disorder
- Clinical assessment of substance use disorders
- Contingency management for substance use disorders: Efficacy, implementation, and training
- Management of acute pain in adults with opioid use disorder
- Use of opioids in the management of chronic non-cancer pain
- Prescription drug misuse: Epidemiology, prevention, identification, and management
- Overview of management of opioid use disorder during pregnancy
